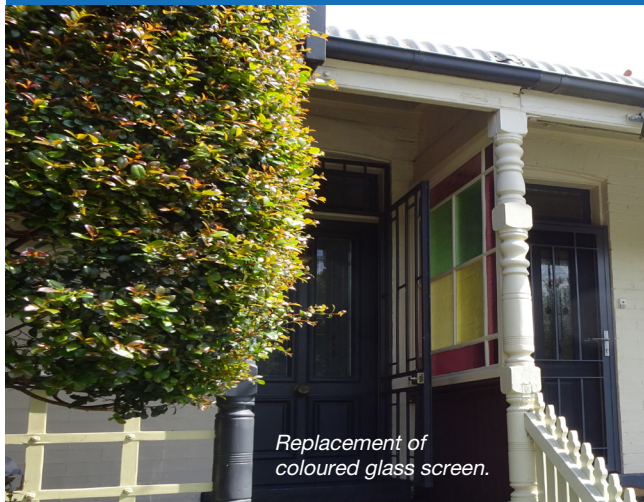


What are the aims of the program?

- Encourage work on heritage items and in heritage conservation areas within the City of Canada Bay
- Assist in reconstruction of missing details to heritage items and encourage conservation work that enhances the public domain within the City of Canada Bay
- Encourage interest and awareness for conservation of heritage sites within the City of Canada Bay
- Promote a positive community attitude towards heritage conservation within the City of Canada Bay.



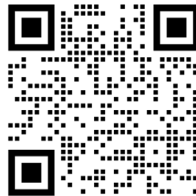

How do I apply?

Please be aware the total amount of funding available for the Heritage Grants Program is limited so Council will not be able to fund all projects.



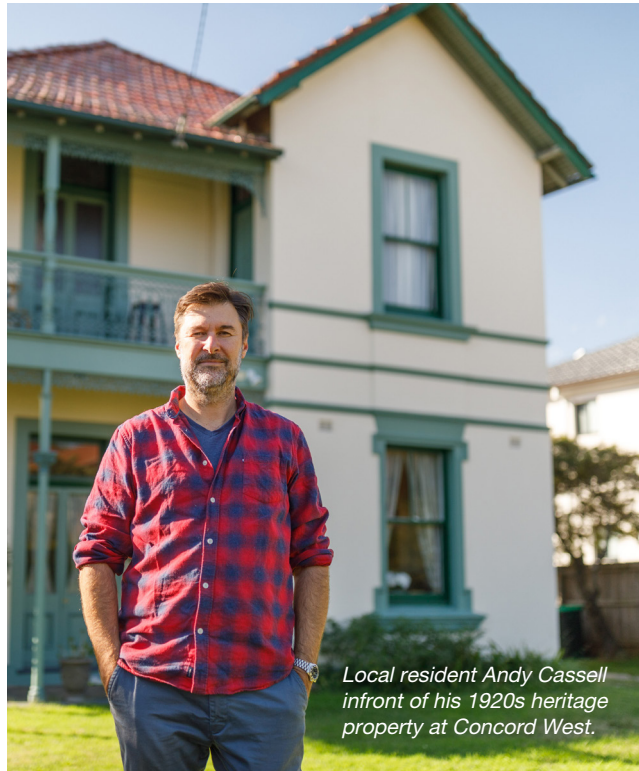

Local Heritage Grants Program 2022–23



We have established a Local Heritage Grants Program to help owners conserve our local built heritage.

- The Program provides dollar for dollar funding to successful applicants for small conservation works
- Up to \$3,000 is available for work to properties that are heritage items
- Up to \$2,000 is available for work to contributory buildings in a heritage conservation area
- There is a total of \$25,000.00 in funding to be distributed for the 2022–23 financial year.



How to apply

Applications can be received at any time after the work has been completed. Minor works approval must be obtained for minor works to heritage items and buildings in heritage conservation areas.

Applicants should:

- Read the 2022–23 Local Heritage Grants Program Guidelines and complete the Application Form
- Provide before, during, and after colour photos of the works
- Provide evidence of costs (invoices) and where relevant, sketches of work/plans
- Provide a copy of the minor works letter from Council for the project.

What projects are eligible for funding?

To be eligible for funding, your work must:

- Be undertaken in accordance with the Local Heritage Assistance Fund Guidelines
- Have received minor works approval
- Enhance the heritage values of the heritage item and/or conservation area
- Be of a high quality.

Types of works eligible for funding include:

- Repairs
- Tuck pointing
- Re-painting
- Reinstatement of missing parts.

What projects are ineligible for funding?

Funding does not cover the purchase of tools and plants, and will generally not be provided where:

- Minor works approval has not been obtained and was required
- The work does not enhance the heritage values of the place
- The work has not been carried out to a high standard e.g. incorrect mortar used, paint has gone on to face brickwork, replacement elements do not match the original
- Substantial assistance has previously been provided
- The work features new additions (including new internal fittings such as kitchens and bathrooms)
- Work is to infill or neutral buildings in a heritage conservation area
- Works are associated with a development application.
