City of Canada Bay Doing Business 2013

The City of Canada Bay is committed to supporting businesses and encouraging investment. Our five departments, including Executive Services; Community Development; Corporate Services; Environment and Planning; and Technical Services and Operations with direction from our nine Council Members (Councillors) including the Mayor work proactively together to exceed expectations.

Property and business owners interact with all departments of the City of Canada Bay with regard to community safety, traffic management, protection of the environment, improving the streetscapes, community services, accessibility, maintaining and enhancing parks and recreation areas, monitoring and controlling the type and quality of developments in the City are areas of focus for us.

In 2008, we developed FuturesPlan20, a 20-year community plan based on what the community saw as its vision for the City. It was updated in 2010 and has just been reviewed, revised and readopted in 2013 after extensive community and stakeholder consultation and engagement. FuturesPlan20 provides a picture of the future of our City that has been developed with the active involvement of the people who live, work and have an interest in our City. It is our collective response to the challenges and changes that we know are coming. It describes our vision for our city and the directions that we will take to promote a strong and healthy community, including addressing economic stability. Our four-year delivery plans and annual operating plans are structured to deliver the long-term key directions of this Plan.

The City of Canada Bay assists the community with transparent governance, delivering on key directions and providing the information you need in a clear and concise approach. This publication provides an overview of our operations in relation to purchasing or leasing a commercial property and/or operating a business within our City. It is important to note that, generally the outgoings associated with a commercial lease including Property Rates, Water Rates, Insurances, Strata Levies, Land Tax and Waste Management are the responsibility of the leasee. It is recommended to undertake a complete due diligence on the property and related fees and charges, prior to signing a contract of sale or lease.

Maintaining low fees and charges

Business Rates Assessments and Levies

Council rates and charges fund services including community services, sporting and recreation services, environmental planning, building regulation, public health, environmental protection and waste collection, treatment and disposal. Council rates are calculated on the property's land value determined by the Land and Property Information Division of the NSW Department of Lands. There are 1634 rateable business properties within the City of Canada Bay.

Fees can be paid annually or quarterly.

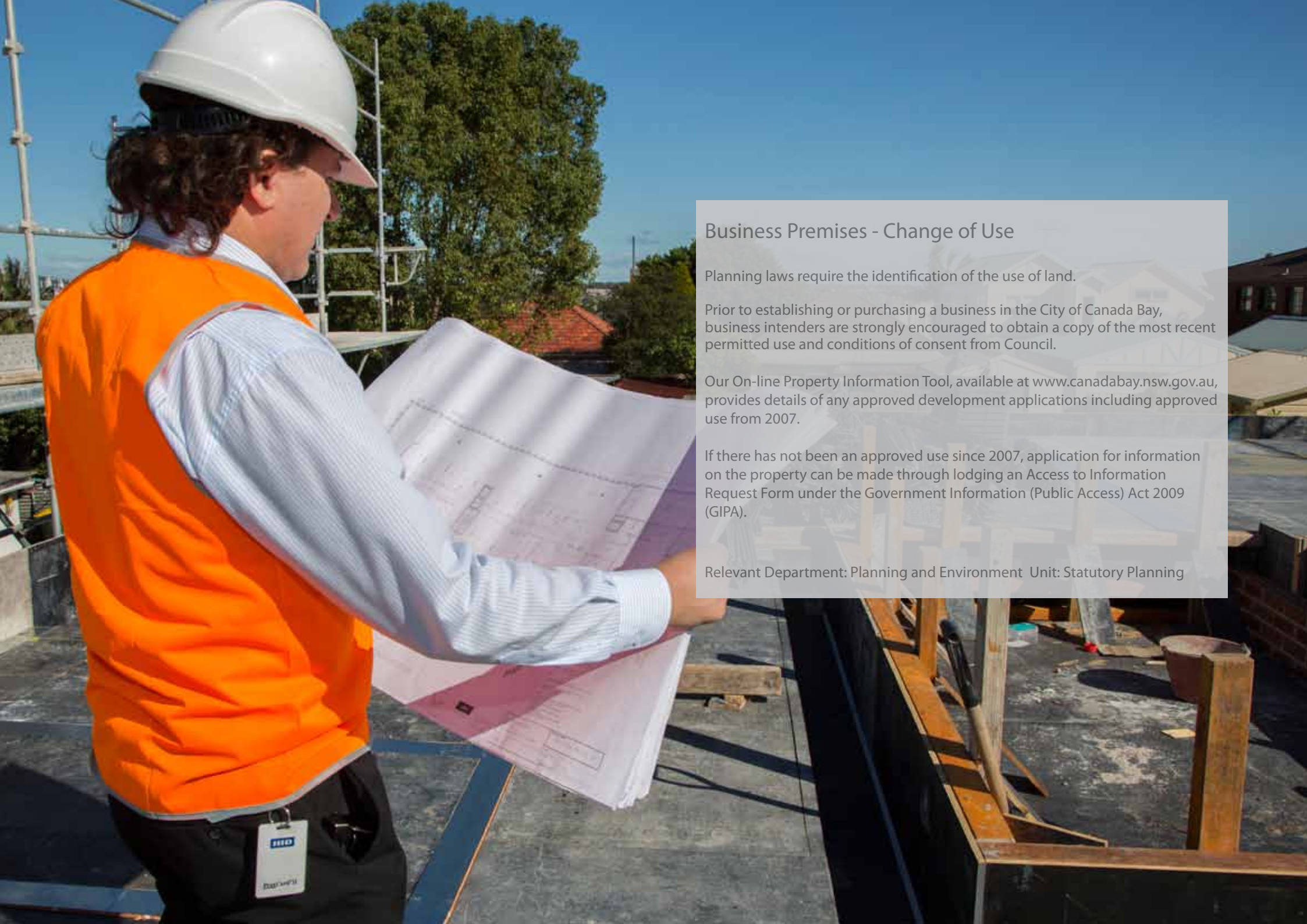

Business Premises - Change of Use

Planning laws require the identification of the use of land.

Prior to establishing or purchasing a business in the City of Canada Bay, business intenders are strongly encouraged to obtain a copy of the most recent permitted use and conditions of consent from Council.

Our On-line Property Information Tool, available at www.canadabay.nsw.gov.au, provides details of any approved development applications including approved use from 2007.

If there has not been an approved use since 2007, application for information on the property can be made through lodging an Access to Information Request Form under the Government Information (Public Access) Act 2009 (GIPA).

Straightforward local planning

Most new businesses require planning consent to conduct business. Prior to commencing a business within the City of Canada Bay, it is recommended to liaise with our Duty Planner.

The City of Canada Bay has a number of plans, policies and strategies that help shape future development within our City. In June 2010, Council adopted the Local Planning Strategy (LPS) which provides a framework for future land use planning of the City of Canada Bay. The LPS aims to provide housing and employment, consider future recreational needs, protect heritage and the natural environment and consider transport in an integrated manner.

It is recommended when considering leasing a commercial property to consult the City of Canada Bay's Local Environmental Plan (LEP) and Development Control Plan (DCP), and/or purchase a Section 149 Planning Certificate, if not provided by the property agent. We have a free Online Property Information Tool which provides basic information relating to a specific property such as zoning, heritage, and development control plans.

- LEP: the principle planning instrument for the local area which is gazetted legislation.
- DCP: Builds upon the LEP by providing detailed objectives and controls for development.

There are two types of Section 149 Planning Certificates which provide information on the zoning of land (how the property can be used) and relevant planning controls (the restrictions on development). It is a requirement of the Conveyancing Act 1919 that a Section 149 Planning Certificate be attached to the contract for sale.

- Section 149 (2) provides information about the zoning of the property, the relevant state, regional and local planning controls, other planning affectations such as heritage, land contamination and road widening and whether complying development can be carried out on the land.
- Section 149 (2 + 5) provides additional advice regarding demolition, foreshore building lines, other heritage considerations and general advice.

In addition, development consent conditions generally identify permitted use, permitted hours of operation, restrict the operating noise level of equipment and plant on industrial and commercial premises and may indicate approved signage.

Exempt and Complying Development: State Environmental Planning Policy (Exempt and Complying Development Codes) 2008 (SEPP) which commenced on 27 February 2009, lists various types of minor residential and commercial development that can be carried out as exempt development or under complying development which may be approved by the City of Canada Bay or accredited certifier.

Limited development within heritage conservation areas is permitted under this Code. If Council's LEP nominates a development type as exempt or complying and the SEPP does not deal with that development type, then Council's current provisions for that development type will still apply.

Footpath and venue spaces available for rent

Business Use of the Footpath

Outdoor dining and use of the footpaths is increasing across the City as local businesses prosper and look for opportunities to create more vibrant and interesting shopping areas. In order to ensure consistency, access and fairness, Business Use of the Footpath Policy applies to business use of footpaths across the City of Canada Bay. To assist local business owners, the City of Canada Bay maintains these fees at a fraction of the cost per square metre of retail space.

Businesses, which would like to use public footpaths for business purposes, must lodge a Business Use of Footpath Application Form with Council, together with a plan showing the dimensions of the footpath area required and any permanent or temporary structures they are wishing to install. Footpath permits are not transferrable between business owners. We will assess the application to ensure compliance with the policy and that any awnings are structurally sound and in keeping within the existing streetscape. Prior to purchasing or leasing a commercial property or making a Business Use of the Footpath Application it is recommended to contact Council's Property Services Team to discuss the policy and what is permitted on the proposed site. Awning structures require a development application. Unlicensed use of public footpath will be fined in accordance with Council's Law Enforcement Policy.

Operating a food business

City of Canada Bay's Food Safety Surveillance Program is aimed at ensuring food sold within our City is safe and suitable. The program is designed to educate food businesses on best practices and regulate food businesses for compliance with legislation. If you operate a food business, you are responsible for ensuring that food prepared by you doesn't make somebody sick.

City of Canada Bay routinely inspects businesses to ensure they comply with the law. We will also provide you with assistance and advice to help you and your business meet the highest food safety standards possible. City of Canada Bay's Food Safety Surveillance Strategy outlines how we undertake inspections and how we will monitor food safety across our City.

Before opening a food business, you must:

- Ensure you have appropriate approval. If you are unsure please contact our Duty Planner by calling 9911 6555.
- Be inspected by our Environmental Health Officer (as per conditions of consent)
- Appoint a Food Safety Supervisor. For further information please visit NSW Food Authority website available at www.foodauthority.nsw.gov.au
- Notify NSW Food Authority of your food business. This can be completed online via www.foodnotify.nsw.gov.au

Operating a beauty business including home-based and mobile operators

City of Canada Bay's Skin Penetration Surveillance Program aims to improve hygiene and infection control standards across the Local Government Area through both education of local business proprietors and enforcement. In addition to development of a range of educational materials City of Canada Bay annually inspects all businesses practicing skin penetrating treatments to assure compliance with legislation. For further information please see the City of Canada Bay Skin Penetration Surveillance Strategy.

Before opening a beauty business (including mobile operators and home based businesses) that undertake treatments that penetrate the skin you must:

- Ensure you have appropriate approval. If you are unsure please contact our Duty Planner by calling 9911 6555.
- Be inspected by our Environmental Health Officer (as per conditions of consent)
- Complete and return Council's Business Registration Form.
- Familiarise yourself with the regulatory requirements for skin penetration businesses as outlined in the NSW Public Health Regulation 2012.
- Visit our website at www.canadabay.nsw.gov.au to access City of Canada Bay Skin Penetration Surveillance Strategy as well as supporting fact sheets.

Treatments that penetrate the skin includes but is not limited to the following:

- Waxing
- Lancing
- Microdermabrasian
- Cuticle cutting
- Ear and body piercing
- Tattooing

NB. Procedures that are not intended to penetrate the skin, such as those offered by hairdressers and barbers are not considered to be skin penetration.

Operating a home based business

Operating a home business or home industry is exempt development (Subdivision 22) under the State Environmental Planning Policy (Exempt and Complying Development Codes) 2008 (SEPP 2008). To comply with the Code, the home business or home industry must not involve the manufacture of food products or skin penetration procedures.

The use of the home to operate a business to be considered exempt development within the SEPP must not involve a change of building use and utilise no greater than 10% of the total floor area (internal). Under the Building Code of Australia, a change of building use involving a floor area greater than 10% of the floor area of a building would cause the building to contravene the development standard.

In addition your home business must comply with clause 5.4 of the the City of Canada Bay's Local Environment Plan (LEP).

Home based food and skin penetration (beauty) businesses

Before operating a home based food or skin penetration business you must:

- Ensure you have appropriate approval. If you are unsure please contact our Duty Planner by calling 9911 6555.
- Be inspected by our Environmental Health Officer (as per conditions of consent)
- Notify your food businesses to the NSW Food Authority. Online via www.foodnotify.nsw.gov.au
- Register your skin penetration business with the City of Canada Bay by completing and returning Council's Business Registration Form.
